1. CHEMICAL PRODUCT AND COMPANY IDENTIFICATION

Product Name: 1-Hexanesulfonic Acid, Sodium Salt or 1-Hexanesulfonic Acid, Sodium Salt, Monohydrate

Synonyms: Sodium 1-Hexanesulfonate Monohydrate; Sodium Hexylsulfonate Monohydrate

2. HAZARDS IDENTIFICATION

4. FIRST-AID MEASURES

Inhalation: If inhaled, remove to fresh air. If not breathing, begin artificial respiration. Get medical aid if victim has difficulty breathing.

Ingestion: Induce vomiting as directed by medical personnel. Never give anything by mouth to an unconscious person. If vomiting occurs naturally, have person lean forward. Get medical aid.

Skin Contact: Wash exposed area with soap and water. Get medical attention if irritation develops and persists.

Eye Contact: Immediately flush eyes with plenty of water for at least 15 minutes, lifting lower and upper eyelids occasionally. Get medical attention.

5. FIRE FIGHTING MEASURES

Flammability: As with most organic solids, fire is possible at elevated temperatures or by contact with an ignition source.

Products of Combustion: Will decompose into toxic and irritating gases (carbon monoxide, carbon dioxide, and sulfur oxides) under fire conditions.

Specific Fire Hazards: As in any fire, always wear self-contained breathing apparatus in pressure-demand (MSA/NIOSH approved or equivalent), and full protective gear. Approach fire from upwind to avoid hazardous vapors and toxic decomposition products.

Specific Explosion Hazards: Fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard.

Fire Fighting Media: Use water, dry chemical, carbon dioxide, or alcohol resistant foam.

6. ACCIDENTAL RELEASE MEASURES

Ventilate area and remove all ignition sources. Clean up spills in a manner that does not disperse dust into the air. Use non-sparking tools and equipment. Reduce airborne dust and prevent scattering by moistening with water. Sweep up spilled material and place in a suitable container. Always use proper personal protective equipment as described in section 8.

7. HANDLING AND STORAGE

Precautions: Employ grounding, venting and explosion relief provisions in accord with accepted engineering practices in any process capable of generating dust and/or static electricity. Empty only into inert or non-flammable atmosphere. Emptying contents into a non-inert atmosphere where flammable vapors may be present could cause a flash fire or explosion due to electrostatic discharge. Always use proper personal protective equipment as described in section 8. Wash thoroughly after handling. Avoid contact with eyes, skin, and clothing. Avoid inhalation and ingestion.

Storage: Keep in a tightly closed container, stored in a cool, dry, ventilated area. Protect against physical damage. Avoid dust formation and control ignition sources.

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Engineering Controls: A system of local and/or general exhaust is recommended to keep employee exposures as low as possible. Local exhaust ventilation is generally preferred because it can control the emissions of the contaminant at its

source, preventing dispersion of it into the general work area.

Personal Protection: Wear protective chemical goggles or appropriate eye protection. For conditions of use where exposure to dust or mist is apparent and engineering controls are not feasible, a particulate respirator (NIOSH type N95 or better filters) may be worn. If oil particles (e.g. lubricants, cutting fluids, glycerine, etc.) are present, use a NIOSH type R or P filter. For emergencies or instances where the exposure levels are not known, use a full-face positive-pressure, air-supplied respirator. **WARNING:** Air-purifying respirators do not protect workers in oxygen-deficient atmospheres. Wear protective gloves and clean body-covering clothing.
