#### 1. CHEMICAL PRODUCT AND COMPANY IDENTIFICATION

## 4. FIRST-AID MEASURES

#### 5. FIRE FIGHTING MEASURES

<u>Flammability</u>: As with most organic solids, fire is possible at elevated temperatures or by contact with an ignition source. <u>Auto-ignition Temperature</u>: Not available.

#### 6. ACCIDENTAL RELEASE MEASURES

Ventilate area and remove all ignition sources. Clean up spills in a manner that does not disperse dust into the air. Use non-sparking tools and equipment. Reduce airborne dust and prevent scattering by moistening with water. Sweep up spilled material and place in a suitable container. Always use proper personal protective equipment as described in section 8.

#### 7. HANDLING AND STORAGE

<u>Precautions</u>: Employ grounding, venting and explosion relief provisions in accord with accepted engineering practices in any process capable of generating dust and/or static electricity. Empty only into inert or non-flammable atmosphere. Emptying contents into a non-inert atmosphere where flammable vapors may be present could cause a flash fire or explosion due to electrostatic discharge.
